

The main concern voiced in the meeting was our limited coaching resource and ability over the summer months to properly look after new rowers during race season. It was suggested that this would be better organised for the Autumn when it would be easier to integrate more rowers in land and weekend water training. Timing: it was agreed that early Autumn would be ideal or beginning of Spring in 2024



It was generally agreed that it is difficult to slot novices into much for experienced crews and that they need to be put into crews with similar experience levels with a request for volunteers to take on coaching for a crew. It was generally noted that there is limited appetite for any individual coach to take on large squads.



A positive month cashflow-wise with additional membership fees of £2.5 and a further £5k of cash from MoS regatta.


On the expenditure side, the only significant non-operating expenditure was the \pm 1,250 we invested on the floating pontoon purchased from Bournemouth.

The Dave Stafford account now has a balance of £3.4k having used £300 of Love Rowing grant to fund Talent ID coaching costs.


