



Review of previous minutes – draft notes for November meeting were approved

Junior Rep – No matters arising this month		
Boats/Kit		
Discussed potential need for a new cox box for the 8+ as the current		
one is not working. There was a bit of a concern about the cost –		
approx. £600. However, given the 8+ campaign and the number of opportunities for getting 2 men's and ladies crews out and the		
positive effect this is having on bringing people together, it was		
agreed that this would be a good investment and was approved.		
Hugo advised that there is a second 8+ available, owned by Dave		
Mans. He paid £500 for it and has done a lot of work to it. It would		
need further work for us to fit out to our requirements but after		
discussion it was agreed that any investment should add value to the		
boat and hopefully could be sold later if not being used. Purchase		
approved by the Committee.		
Focus remains getting rid of the Trafalgar.

Pete has sourced some strong pallets which could replace some of the		
broken trolleys. The cost is £75 and it was agreed that he should go		
ahead and purchase these.

Treasurer's Report – Fee


The Financial Report was circulated in advance of the meeting and is attached below. Overall, we are in a reasonable financial position despite the investments made over the last couple of months in new boats/ergs. Our cash balance is in excess of £16k which is significantly more than we would usually expect at this point in the season especially after the investments we have recently made.

Stan raised a question about the payment to Castleford which appeared too low but Fee explained this is only the payment made in October and not to charge for the full year.

Noted that the bus service and MOT is coming up in the new year.

Safety Report – Jane

Jane had circulated the BR safety report in advance of the meeting. There has been only one incident of a pair getting close to the ferry. There was no collision and a report was made to the Harbourmaster as is required.



December Committee Meeting 2021

Captain's Report

November has seen the club getting stuck into the winter training and competing in Head races where possible. There has been good participation in the ergo sessions, particularly Men and Juniors where 12 ergos per session are often in action. We have also begun to get the 8 project rolling.

On 6th November we took our a big entry to Henley Sculls with everyone enjoying the chance to get racing on the historic course.

- Tim and Kenny once again were comfortable winners in Masters E
- Callan came a highly impressive 5th/25 in J16 sculls with Ellie 8th/13 in W1x.
- Elsewhere there were many other solid performances –Angus and George were 10th/12 in J16 2x, Jack 21st/45 and Seb 33rd/45 in J18 Sculls, Annabelle 24th/26 in J18 sculls, Pippa 13th/23 in J16 Sculls

Sadly, Burway Small Boats Head on 27th November, where we had a big entry at Junior Level as well as Ellie in 1x and Tim and Kenny in 2x was cancelled due to high winds.

However on the 28th November, 2 scratch eights (1 men and 1 women) competed at Wallingford Head where some 238 4s and 8s were competing.


Both crews emerged from the water with big smiles on their faces despite the freezing conditions with the Men's 8 finishing $13^{th}/22$ in Open 8s Band 3 and the Ladies 8 $15^{th}/18$. These performances were particularly noteworthy given that in some cases it was the 1^{st} time they had rowed in an eight!

As we look forward into December, we have several of the J16-18 crews competing at Hampton Head on 4th December with some of the others and the J15s/14s doing BRIC. We also have a pair entered at Walton.

Aside from this the focus is on getting the 8 projects rolling with an ambition to being able to field 2 Men and 2 Women's 8s at some heads in the New Year.

We also have the Club Regatta on 18th December with scratch crews racing in the lagoon and Christmas Puddings for the fastest crew!

After Christmas as well as running the 8 project we will look to start building crews/squads for the Hants and Dorset season. I think it is important for everyone that we are clear on what we are looking to race but we should be competitive at most categories and it is important we plan for this accordingly.



Equipment Update

We have made little progress on the equipment at the moment and continue to look speculatively for a 4-/x- and a 2-/x.

We still need to now focus on sorting out the storage at Brian Goodall's

- Winterising Skylarc
- Getting the Frank undercover and repair underway Getting the Eton down and up and running.
- Tidying up Trafalgar and selling.

Decisions Required – We have the opportunity to purchase a second 8 off Dave Mans for £500 which would need to be fitted out (Pete to provide a quote) but it would potentially enable us to run 2 8s for the 2022 season.


Purchase of at least 1 new cox box – the current one is intermittent at best and a working one is important.

Coaching Update

No progress has been made in this area since the question comes back to how this is funded. Secondly, at present it is difficult to be clear on what our specific needs given we are still bottoming out racing squads.

From my perspective, I would welcome input from the committee but personally I think we need to start putting a fund aside to support the recruitment of a coach for the long term if we want to maintain momentum with the club.

This may result in the short term of us having to hold off on further equipment purchases save points above. However, it would if done correctly underpin the club in the future thereby avoiding the usual cycle of coaches, enable us to look to partner with local schools and develop our club further.

Finance Report for November 2021

November has been a quieter month on the spending front with our only significant expenditure being the purchase of one further ergo for £700 and the service of the RIB for £311.

Our cash balance was topped up by £3.4k from the GWR challenge - with £741 coming in from the sponsors and £2.6k from HIWCF.
